SUBSCRIPTION AGREEMENT: Access to a county’s land title information is by subscription agreement (click on the county’s name below to view its subscription agreement), which can be terminated by a customer, *without penalty*, with 30 days notice. Access includes the geographically-indexed title plant, county clerk’s grantor/grantee index, appraisal (CAD) data, copies of recorded real property documents and maps, and copies of prior commitments and policies. The billing components are:

- Subscription Fee
- Search Fees⁴
- Digital Document Fees [copies of recorded documents and maps]
- Digital Starter Fees [copies of prior commitments and policies]
- Court Docket and Document System Fees [copies of civil court dockets and case documents]

EXPANDED COUNTIES PROGRAM: Subscription fee-free access to 28 metropolitan counties located outside the Houston area (including Brazos County) is available through TDI's [Expanded Counties Program](#) – begin to earn bonus counties when subscribing to *two* or more of Houston's “Big Five” counties (Brazoria, Fort Bend, Galveston, Harris and Montgomery).

COURT DOCKET AND DOCUMENT SYSTEM FEES

Digital images of dockets and associated case documents for many of the civil courts (state district, probate, and county) can be retrieved from the Image Library. There is no cost to view and/or print a docket. The charge to view and/or print the case documents linked to a docket is \$9.00 total for the case documents, whether a customer elects to view and/or print one or one hundred. Subscribers have access to the dockets and associated case documents for those courts located in a county under subscription.

DIGITAL STARTER FEES

Over 5,000,000 title insurance commitments and policies are linked to the applicable parcels in the geographic index portion of the Title Plant. Copies of digital commitments and policies cost \$30 each and a subscriber has access to commitments and policies which pertain to those counties under subscription.

⁴Search Fees

- There are *no* Search Fees for Brazos County
- A customer is only billed a single fee, whether the search is viewed, printed or both.
- A range search is billed as two searches.
- Within search types, searches run during the monthly billing period for *all* counties under subscription count towards achieving the higher-volume price point.
- There is no Search Fee for searches of the Imaged Backplants.
- County clerk's grantor/grantee index searches, appraisal (CAD) data searches, and selected title plant searches (document reference, remark, and address) are *free*.

⁵Digital Document Fees

- Digital documents consist of (i) documents recorded in a county clerk's real property records, (ii) recorded maps (plats), (iii) proprietary acreage maps and (iv) Imaged Backplants.
- A customer is only billed a single fee, whether the document is viewed, printed or both.
- Documents retrieved during the monthly billing period for *all* counties under subscription count towards achieving the higher-volume price point, except documents retrieved from the Montgomery County imaged backplant.
- Copies of the Montgomery County imaged backplant cost \$.15 per document.

- Copies of digital documents retrieved cost \$1.00 per *document* for customers not subscribing to the title plant for which the digital document pertains.
