Bell: also includes maps filed in the deed records, which start DE/510 [April 18, 1855]

Brazoria: also includes Federal Land Bank documents [3 volumes] from August 1917 through September 1928; beginning with M2005/25180 county clerk files maps in the OPR, which TDI converts to M MAP records; for example, document 2007019056 converts to M MAP record M2007/19056

Caldwell: also includes maps filed in the deed records from DC/355, May 1893

Chambers: also includes mechanic's lien documents; beginning with M2005/10376 the county clerk follows the same format as Brazoria County

Collin: M1/1 thru M12/164; then county clerk changed to MB/99 thru MR/262; then county clerk changed to M2006/1 thru present

Comal: begin Volume B; minimally incomplete from the 1970s to the early 1990s; M1/1 thru M15/381, then county clerk changed to M2006/1005 (clerk's file no. 200606001005) thru present

Dallas: Title Data provided Dallas County Clerk John Warren with a spreadsheet of approximately 65,000 documents from the 1964 through 2005 time frame which his office has not digitized; Mr. Warren has committed to filling these gaps; in the interim customers should contact the Dallas County Clerk's office for copies of these missing images.

Denton: Inconsistent [gaps] 1851 through 1875; MA/2 thru MY810, then county clerk changed to M2009/1 thru present

El Paso: deed of trust documents begin 1977; M1/1 thru M80/122, then county clerk changed to M2006/2647 thru present

Fort Bend: P1/2 thru P2573A, then county clerk changed to P2004/1 thru present

Galveston: Map records M1/1 thru M18/1407, then county clerk changed to M2003A/1 thru present; while separate condo records do not exist at the county clerk's office, TDI has artificially created condo records

- Harris: Volumes 3768, 3769, 3798, 3810, 3811, 3842, 3847, 3848, 3850 and 3853 are missing from the county clerk's office; also includes contract records from Volume 1 (June 1872) through Volume 1151 (June 1959)
- Hays: alpha deeds 1848 thru 1891; numeric deeds 1866 thru 1969
- Nueces: Oil & gas documents start February 18, 1915; subdivision portion of the backplant ends 12/31/1955
- Montgomery: M1/1A thru M8/45, then county clerk changed to MA/1A thru present
- Tarrant: M88A/81 thru M88Z/140, then county clerk changed to M88000/1 thru M880219/16, then county clerk changed to MA/25 thru present. The subdivision portion of the backplant starts January 1891
- Waller: there are no map records per se; maps are interspersed in the OR and deed records
- Williamson: also includes some deeds from 1848 through 1933; MA/1 thru MZ/397, then county clerk changed to M2010/67554 thru present (maps linked to MP records)
- Backplants: in Bexar, Fort Bend, Galveston, Harris, Nueces and Tarrant counties they are tract books; in Guadalupe and Montgomery counties they are take-off cards [some of which, in the case of Montgomery County, date back to 1940] and Copy Flo prints [Montgomery County]; in El Paso the backplant is both tract books and take-off cards.
